Purpose

The Learning, Quality and Standards Committee (LQSC) is responsible on behalf of the Academic Council for the oversight of the university's strategy for learning and teaching, as part of the University's Academic and Student Experience Strategy.

Its remit includes the development and implementation of policy and procedures relating to the academic quality and standards of all academic provision within the university and of the academic programmes offered by partners in the UK and overseas which lead to University of Greenwich awards or recognition of credit.

Terms of Reference

- **1.** To consider and develop, for approval by the Academic Council, strategies for the enhancement of learning and teaching, including technology-enhanced learning to enhance the quality of students' learning opportunities and learning experiences.
- 2. To formulate, monitor and develop university policy and regulations related to academic provision, including learning, teaching and assessment, quality assurance and quality enhancement and academic standards for approval by the Academic Council.
- **3.** To approve, under delegated authority, procedures, guidance, and good practice related to areas within the committee's remit.
- **4.** To promote a culture of reflection, excellence, and innovation in professional practice in learning and teaching so as to maximise the individual potential and satisfaction of students.
- 5. To facilitate and monitor faculty implementation and operation of university policy and procedures relating to academic provision, including learning, teaching and assessment, quality assurance and quality enhancement and academic standards and report to the Academic Council accordingly.
- **6.** To scrutinise the monitoring of all the university's awards, including those in partnership provision.



- **7.** To consider an annual summary from each faculty of trends and lessons learnt from annual programme reviews.
- 8. To consider the outcomes of each annual portfolio review cycle.
- **9.** To ensure institutional oversight of the quality and standards of campus-based and partnership provision through the analysis of statistical data and other information.
- **10.** To receive, as appropriate to the maintenance of quality and standards, reports from relevant directorates, partners, and faculties in relation to both campusbased and partnership developments and issues; including Student Activity Reports summary;
- **11.** To discuss and agree actions to be taken in relation to the quality assurance, monitoring and enhancement activity of external agencies, including: OfS, QAA, Ofsted, PSRBs, NHS, HE Academy, Research Councils, and to monitor follow-up actions as required.

To make recommendations to Academic Council on:

- **12.** Any developments or changes to university regulations and policy for quality assurance.
- **13.** Any developments or changes to university regulations and policy relating to academic quality and standards.
- 14. Any developments to learning and teaching strategy and policy.
- 15. Any developments or changes to academic regulations.
- **16.** Any proposed changes to university policy and regulations relating to collaborative arrangements.

To approve on behalf of Academic Council:

- 17. The appointment of External Examiners.
- **18.** The university's quality assurance guidance and procedures.
